



## DCK Firearms & Consulting LLC Range Rules

1. **ALWAYS** treat your firearm as if it is loaded
2. **ALWAYS** point your firearm down range
3. **ALWAYS** keep your finger off the trigger until ready to shoot
4. **ALWAYS** be aware of your target and what is beyond it
5. In the event of a **firearm malfunction**, the shooter shall keep his/her firearm pointed down range, raise their hand and advise the range master of the malfunction, so the problem can be resolved.
6. **All firearms** on the firing line must be grounded and unloaded, with actions open whenever anyone is downrange.
7. **ALWAYS** wear eye and ear protection.
8. **DCK does not allow** uncased firearms outside of your shooting lane.
9. **DCK does not allow** loading your firearm outside of your shooting lane or until instructed to do so.
10. **DCK does not allow** reaching beyond the firing line.
11. **DCK does not allow** use tracer, birdshot.
12. **DCK does not allow** drawing from a holster and fire unless that is the training being instructed or prior approval from DCK staff.
13. **DCK does not allow** fully automatic fire unless you are a peace officer. (inform rangemaster prior to arrival).
14. **DCK does not allow** open-toed shoes, sweats or shorts.
15. **DCK does not allow** alcohol, illegal drugs, or any other form of impairment while on DCK property.
16. **DCK does not allow** food or drink on the range.
17. **DCK does not allow** smoking or smokeless tobacco on the range.
18. **DCK** recommends **washing your hands after training**
19. **DCK does not allow Minors** (below 16 years of age) on the range.
  - For Minors under the age of 16 see DCK for more information
20. **Non-shooters** must remain at least six feet behind the firing line whenever any shooter is at the firing line.
21. **DCK does not allow** any shooting at flying or thrown objects.

### Range Safety Officers

\_\_\_\_\_ **DCK requires any person** on the range to obey the range commands of DCK Safety Officers. This includes, but is not limited to: Begin Fire commands, Cease Fire commands, and Resume Fire commands.

\_\_\_\_\_ **Range Safety Officers** may call a Cease Fire at any time an unsafe condition is recognized on the range. Any person on the range shall immediately obey a Cease Fire command by grounding all firearms with actions open.

\_\_\_\_\_ **It is unlawful** for any person on the range to disregard Range Safety Officer warnings concerning failure to obey any range rule.



**RELEASE AND INDEMNITY AGREEMENT**

In consideration of being permitted to enter the facilities at DCK Firearms & Consulting LLC, and/or being permitted to shoot and/or observe any activity thereon, I, on behalf of myself, my heirs, successors and assigns and such parties for whom I sign (collectively “Releasors”) their heirs, successors and assigns agree that I;

Possess at least a basic understanding of firearms.

\_\_\_\_\_ Release and forever discharge DCK Firearms & Consulting LLC, its affiliated LLCs and operations, its members, property owners, employees, agents and related parties (“DCK”) from all liability to the Releasors for all loss, damage, claims or demands on the account of any injury to person or property, including death, however caused, whether by negligence or gross negligence of DCK or otherwise, while the Releasors are on or upon the DCK premises.

\_\_\_\_\_ Will indemnify, defend and hold harmless DCK from any loss, liability, damage, or cost incurred due to the presence of the Releasors on the premises for any purpose.

\_\_\_\_\_ Assume all liability and pay for any damage to DCK property or damage to any other’s personal property, or injury to any other person due to any action whether it is negligent or an intentional action; and

\_\_\_\_\_ Acknowledge that no representations, statements or inducements apart from this written agreement have been made to me.

\_\_\_\_\_ Payment will be collected for all DCK equipment damaged in reference to clause 4 above including but not limited to tables, counters, range guns, target carriers, trash cans, any part of the shooting area and benches.

***By my signature, I acknowledge that I have read, understand, and agree to the policies and procedures of DCK Firearms & Consulting LLC rules, regulations and indemnity as defined in the above that I received.***
